## **Project description**

This project examines the quality of politicians, with a particular focus on how citizens assess it. Beyond ideology, we explore whether MPs can effectively perform and implement their ideas — something shaped by their effort and policy influence. The project develops a comprehensive index of MP quality always with a close focus on which qualities voters value most. In a second step, we analyze how these factors influence vote choice, and how the role of quality in elections can be strengthened.
